**RESOLUTION 2025-5**

**AMENDING WATER RATES AND CHARGES**

WHEREAS, the Elizabethtown Area Water Authority ("Authority") is a municipality authority incorporated, organized and existing under provisions of the Municipality Authorities Act, as amended and supplemented, of the Commonwealth of Pennsylvania, this Authority having been incorporated pursuant to an Ordinance of the Board of Elizabethtown Borough, the Supervisors of Mount Joy Township, and the Supervisors of the Township of West Donegal, Lancaster County, Pennsylvania; and

WHEREAS, The Authority owns and operates water facilities necessary to provide water to customers in the Borough of Elizabethtown, the Township of Mount Joy, and the Township of West Donegal (the "Municipalities"); and

WHEREAS, This Authority, in accordance with power vested in it by law, desires to modify, fix and charge water rates and other charges for use of its water system and for services rendered by this Authority in connection therewith.

NOW THEREFORE BE IT RESOLVED by the Board of this Authority, as follows:

**SECTION I - WATER RATES AND CHARGES:**

Water rates and other charges, modifying Section III of this Authority's Resolution of December 14, 2004 and subsequent modifications, are imposed upon and shall be collected from the Owner of each Improved Property, which shall be connected with the EAWA Water System in in all three Municipalities, for use of the water system and providing of water, whether such use be direct or indirect, which water rates and charges shall commence and shall be effective as of the date of the connection of each such Improved Property to the EAWA Water System, and shall be payable as provided herein.

**SECTION II - COMPUTATION OF WATER RATES AND OTHER CHARGES:**

A. Refer to Exhibit "A" for revised water rates and charges.

**SECTION III - INVALIDITY:**

In the event any section, paragraph, sentence, clause, or phrase of this Resolution shall be declared invalid or unconstitutional for any reason, the remainder of this Resolution shall not be affected thereby.


SECTION IV - EFFECTIVE DATE:
